For the correction and prevention of iron deficiencies, apply as needed.
Tree Crops: Including but not limited to: Fruit (Citrus, Apples, Apricots, Cherries, Pears), Nuts (Almonds, Pistachios, Pecans, Walnuts), Tropical (Mango, Coffee, Cocoa, Papaya, Avocado), etc.	2-4	Deciduous crops: Apply once full leaves have emerged and apply as needed until leaf drop in the fall. Non-Deciduous Crops: Apply before or after vegetative or reproductive stage transitions (flowering, leaf or root flush, fruit set)
Berries and Small Fruit: Including but not limited to: Grapes (Table, Raisin, and Wine), Strawberries, Blueberries, Raspberries, etc.	1-2	Apply as needed.
Grass and Forage Crops: Including but not limited to: Alfalfa, Timothy, Fescues, etc.	1-2	Apply as needed.
Turf and Ornamentals: Including but not limited to: Sport Turf, Landscaped Turf, Flowering Plants, Leafy Plants, Palms, Cut Flowers, etc.	1-2	Apply as needed.
